Water / Sewer Report:

Craig Larson for the month of July 2022. 526.4 thousand gallons were pumped through the tower. Will be flushing hydrants. Still waiting on receiving on the endpoint communicators. Need some plumbing work done at the water plant when the plumbing work is being done at the new building at 105 N 1st St. 0.31 million gallons were pushed out to the ponds. Was a dry month in July. Pond levels are looking good. Need to do some tree trimming out there. The sheep are gone now.

<u>1989 Chevy Truck (old snowplow truck)</u>: The city clerk contacted Govdeals to set up an account and post the truck online. The online auction took place and the reserve was placed at \$2,500.00 for the truck. At the close of the online auction the truck sold for \$3,035.00. The city clerk will be in contact with the winning bidder in the coming weeks to schedule pick up for the truck. The city clerk also had to get a replacement title for the truck as there was not one to be found in the city records between the water plant building and city hall. The IA DOT was contacted and a replacement title was issued.

Reports

<u>Streets:</u> There has been issues with emergency services not being able to find city home addresses. The city is looking into putting up signs to clarify N and S street addresses. The city clerk will order signs saying "S Second St and N Second St' with an arrow pointing the direction of the street. The city clerk will post the snowplow operator position to be reviewed at the October meeting.

<u>Parks</u>: Councilman Adson scooped the rock under the play equipment. Will be doing picnic table repairs.

<u>Waste Management</u>: Purchased \$90,000 worth of sand to backfill waste at the landfill. Got the water truck, have the upcoming slope stability study through the DNR, due to the census numbers in fort dodge they will be cutting back their board members to 4 instead of 5.

Building Permit Committee: no permits were rec'vd.

Fire: no report this month.

Community Hall: The city clerk reported no rentals for the month of August, the owner of Mrs T's Mercantile is interested in hosting a sewing retreat at the hall in September and South Enes Church is interested in renting the hall in October for an event. The city clerk needs to update the agreement to let patrons know we have hooks installed for 'tulle' if patrons are interested in contacting a licensed vendor to put it up for their event.

<u>Mayor</u>: Contacted Arends Construction on when they are expecting to come in August. Contacted Badger Meter regarding the endpoint communicators, they will be Verizon endpoints and scheduled to arrive end of September. Fielded a concern regarding suspicious activity at the park. Councilman Adson and Mayor Adson checked out the community hall for any forced entry; none found. Fielded a safety concern on an out of town fire department member running the stop sign next to the park with a blue light on going to a call. Contacted the property owner of 106 N 1st St multiple times regarding the over growth of weeds at the back of the property.

<u>Clerk:</u> Sent letter to Kathy Hansel regarding property lines request, contacted Colin at gov deals to assist in the sell of the old snow plow truck, IA Dept of Revenue has updated the pay sequence for sales tax and water excise tax monthly, submitted the 2022 work comp audit, posted the old snow plow truck on gov deals, contacted the IA DOT for a replacement title for the truck, will be taking off August 19 and 22, updated the city website, continue to file away city records and organize them, sent the endpoint agreement to residents, enrolled in the SFR class on 8/15/2022 via Zoom, mailed the owner of 106 N 1st St a nuisance letter regarding the backyard, contacted the city insurance agent to add the flashing beacons to our insurance policy and Mike from Badger Meter contacted me after speaking with the Mayor to give an update on the endpoint communicators.
