## **Chickens within City Limits:**

The council and mayor have fielded some concerns from residents regarding chickens in town running loose and chickens being within city limits. Discussion was held in regards to having fowl within city limits. Corey Rutherford is going to look into ideas for what to put in an ordinance and the city clerk will reach out to other cities to get examples to review. Will put this topic on the September council meeting agenda to review samples of ordinances to put a chicken ordinance in place for Vincent.

### **Public Comments:**

Don Sampson inquired what the animal ordinance stated before the 2019 Ordinance was put in place. He also commented on the smell from the UAN tank at the New Coop Seed Warehouse south of town and he asked about the jake brake ordinance within Vincent city limits. If he notices a smell in future he can contact city hall and the city will contact new coop about the smell.

## Water / Sewer Report:

Craig Larson for the month of July 2023: 647.7 thousand gallons were pumped through the tower, still having issues with the High Service Pumps shutting off. Working on replacing the vent pipe for the furnace at the water plant. Had a sanitary survey from the DNR on Monday, August 7<sup>th</sup>, need to get a disinfectant byproduct rule monitoring plan in place. 0.4936 million gallons were pushed out to the ponds. Pond levels are looking good. The sheep are back at the ponds. Would like to start driving the bacterial water sample to LGI (Ag Source) instead of them charging the city to pick up the sample.

## **City Cameras:**

Kyle from Modern Sound Engineering is looking into camera system update options after attending the May meeting and discussing it with council. The estimates were not ready for the August meeting. Will revisit this topic at the September meeting.

## **Nuisance Abatement:**

The city clerk mailed a weed nuisance letter to 211 Lawrence St.

### 105 N 1st St:

Councilman Adson reached out to get pricing on 3/8 minus rock to put around the building. The rock will be delivered when Gary Dencklau gets a chance.
